# Introduction

Strengthening Ireland's connections with our Irish citizens and people of Irish ancestry worldwide is a key objective of the Department of Foreign Affairs and Trade. 'Global Irish – Ireland's Diaspora Policy'; published by the Government in 2015 sets out an ambitious vision for 'a vibrant diverse global Irish community, connected to Ireland and to each other'. These Irish communities are made up of Irish emigrants, their descendants and those living abroad who share and celebrate an Irish heritage identity and global links with Ireland.

Central to achieving the objectives of the Diaspora Policy is the Emigrant Support Programme (ESP), which is administered by the Irish Abroad Unit (IAU) of the Department of Foreign Affairs and Trade in Dublin, in partnership with Irish Embassies and Consulates abroad.

Given the number of strong Emigrant Support Programme (ESP) project applications received, an additional €225,000 was allocated to the ESP from savings elsewhere in the Department to increase the overall expenditure under the ESP. For the first time in 2017, the Department was allocated an additional 'Diaspora Affairs' budget line. This budget line had previously been administered by the Department of the Taoiseach.

Over the course of 2017, a total of 396 Projects from 260 different organisations totalling some €12.5 million<sup>2</sup> were funded through IAU: €11.82 million through the Emigrant Support Programme and €0.68 million through the Diaspora Affairs budget line.

# **Emigrant Support Programme**

As set out in the Government's 2015 Diaspora Policy, the Emigrant Support Programme (ESP) is a tangible expression of the Government's support of, commitment to and interest in the global Irish community. Through this important Programme, the Government aims to strengthen the international Irish community and its bond with Ireland.

This ongoing commitment allows the continuation and development of the important work of Irish organisations and communities across the world in support of Irish emigrants and the wider Irish diaspora.


Since its inception in 2004, the Emigrant Support Programme (ESP) has assisted over 573 organisations in 34 countries with grants totalling over €159 million. Grants have ranged from small amounts for small voluntary groups, to major allocations awarded to community organisations operating on a large scale.

In 2017 there was over 420 applications from more than 20 countries requesting over €20 million worth of funding for the Programme's €11.595 million budget. The amount of funding awarded in 2017 was €11,819,907 to 252 organisations for 387 projects in 23 countries.<sup>3</sup>

In addition to the expenditure resulting from the annual Emigrant Support Programme on-line grant round, further funding of €56,116 was allocated through the process known as the 'Mission Fund'. In 2015, in response to the commitment in the Diaspora Policy to look at ways of simplifying the application process for recipients of amounts less than €5,000, a special category known as the Mission Fund was developed, targeted at small projects which foster vibrant and diverse communities abroad. This Mission Fund grew from funding 5 projects in 4 countries totalling €7,104 in 2015, to funding 20 projects in 11 countries totalling €32,459 in 2016, and a total of 17 projects in 10 countries in 2017.



Separately, in 2017 a new 'Strategic Diaspora Project' stream was created within the Emigrant Support Programme funding allocation, on a pilot basis, to assist our Embassies and Consulates abroad to use their experience, reach and unique perspective to identify overarching projects with strategic importance for our Communities abroad. In particular this new category assisted our Missions in responding quickly to urgent needs of Irish citizens abroad that they identified, and to be able to respond affirmatively and quickly to requests for diaspora related projects to be taken forward in partnership with local governments where Ireland has a strategic interest in developing positive relationships. Funding totaling €147,520 was allocated to 8 projects in the United States, Britain and Canada under this new category. This included additional funding to support our undocumented citizens in the US in response to legislative changes there over the course of the year, through our Embassy Washington and our Consulate General in New York.




### **ESP Expenditure by Geographical Region**

Britain continues to receive the highest percentage of funding under the ESP. In 2017, projects taking place in Britain represented 45% of total ESP funding allocated worldwide, with the USA second at 34%.



Over half of grants issued through the Emigrant Support Programme are small grants, under €10,000 – this includes some 86 grants (34%) which are under €5,000. At the other end of the scale, there were 15 grants for amounts larger than €200,000.


### ESP, MF & SDP Funding paid to organisations in 2017 by Region







### **ESP Expenditure by Category**

The Government's vision, set out in the 2015 Diaspora Policy, of supporting, connecting with and facilitating 'a vibrant, diverse global Irish community, connected to Ireland and to each other' is given particular practical expression and visibility through the different funding pillars of the Emigrant Support Programme. Through the ESP, the Government supports projects in categories including Welfare (Elderly); Welfare (Other); Culture/Sport/Heritage; Capital; Business.

As set out in the Diaspora Policy, through the ESP, the Government continues to prioritise financial support to organisations engaged in the delivery of front line advisory services and community care to Irish emigrants, particularly to the more vulnerable and marginalised members of our community abroad, including the elderly. In 2017, €7,251,669 of the €11,819,907 awarded, representing 61% of total funding awarded, was under the welfare categories. This reflected a total of 197 separate projects representing over 50% of the total number of projects funded under the Programme.

### **Collaboration with Irish Cultural Organisations**

There are over 420 GAA clubs outside of Ireland in 45 different countries worldwide.

For over a decade the Department has had an established funding partnership in place with the GAA for Games and Community Development officers in Britain and in areas of the US with grant funding of €250,000 allocated for this purpose in 2017.

In addition, since 2013, through the Global Games Development Fund, the Department of Foreign Affairs and Trade and the GAA



have provided funding for developmental projects in GAA clubs in Asia, Australasia, Canada, Europe, the Middle East, Africa and South America. This Fund provides financial support specifically for projects and initiatives that increase or improve opportunities for the Irish Diaspora and other communities abroad to play Gaelic Games, thereby strengthening Irish networks and Irish identity internationally, nurturing a sense of Irish community and creating important links between the global Irish and their local communities.





From supporting 14 projects in 2013, the Global Games Development Fund has grown to contribute funding to 59 different projects across the globe for 2017. Some projects are one-off events, others have activities lasting the course of a year. In 2017 the Department contributed €135,000 to the GAA for the Global Games Development Fund, this amount being matched by the GAA to complete the budget for the year.

The Department also collaborates closely with Comhaltas Ceoltóirí Éireann in promoting Irish culture worldwide and fostering a deeper sense of connection amongst the Irish diaspora to their roots. With the assistance of funding through the ESP, Comhaltas use Irish music to reach out to the younger generation of Irish communities abroad and to our affinity diaspora. Last year saw €245,000 allocated to Comhaltas under the ESP for activities in Britain, North American and Canada, along with the expansion of Comhaltas into Japan.


#### **Audit and Quality Assurance**

The Department is firmly committed to ensuring best practice monitoring of the financial expenditure associated with Emigrant Support Programme grants. Between 2014 and 2017, Irish Abroad Unit has undertaken 28 routine audits of ESP organisations using an external supplier. The annual figure more than doubled this year - with 11 organisations being audited, (2014-6; 2015- 6; 2016- 5) at an overall cost of €54,389. The 2017 schedule included an increased audit programme in respect of organisations in Ireland, maintained our regular audit level in Britain and extended our audit reach to Canada. At the time of audit the 11 organisations had all been in receipt of a 2016-17 grant, of which: 3 were less than €50,000; 2 between €50,000 &

€100,000; 4 between €100,000 & €200,000; and 2 of over €200,000. The auditors considered such areas as governance and management structures, board composition & rotations, value for money, that the grant had been used in accordance with ESP objectives, spent as per the agreed terms & conditions and accounted and reported properly. Organisations actively engaged with Irish Abroad Unit and relevant embassies on the findings and addressing recommendations.

### **Global Irish Civic Forum**

The second Global Irish Civic Forum took place on 4-5 May 2017 in Dublin Castle, with the theme "Communities, Connections, Conversations". As was the case with the first Global Irish Civic Forum held in 2015, Irish community leaders from around the world, drawn from emigrant and diaspora communities, came together to discuss the challenges facing the Irish abroad. The Forum brought together over 220 attendees, representing over 150 organisations working with the Irish diaspora globally.





Panel discussions took place on key current thematic issues including: Evolving Global Irish Communities – meeting their needs and identifying opportunities for collaboration; Communicating Better in a Digital Age – using new tools to stay connected; Imagining an Irish Culture for the Future – representing a new Ireland and engaging future generations of the Irish abroad; and Voting Rights in Presidential Elections; as well as Workshops and sessions on specific topics including returning emigrants, our undocumented citizens in the US, mental health of citizens abroad, governance, fundraising, cultural programming and planning for the future.<sup>7</sup> Participants engaged deeply and energetically on the topics for discussion, and this positivity was reflected in responses to the feedback survey which issued to all attendees. The Forum received very high satisfactions ratings, and 65% of attendees reported they had made lasting connections with new organisations and individuals. The Report of the Civic Forum identified seven key themes for follow up, resulting in 21 commitments made by DFAT, all of which have either been delivered or are underway. The total cost of the Civic Forum in 2017 was €69,751.

### **Presidential Distinguished Service Awards**

The Presidential Distinguished Service Award, administered by IAU, remains an important symbol of the importance placed by Ireland on the global Irish, their contributions and their achievements.

While the PDSA scheme was originally designed to recognise 'Irish citizens, those entitled to Irish citizenship and persons of Irish descent who have made a sustained and distinguished service to Ireland or Irish communities abroad', following a review by the High Level Advisory Panel, the Government decided in October 2017 that this emphasis should be widened to include recognition of those individuals with Irish connections who have given sustained or distinguished contribution on global issues, which may not have a specific Irish or Irish community connection. It is hoped that this change will widen the reach and impact of these important awards and demonstrate the importance of broader global values in our recognition of the Work and achievements of Irish individuals and communities worldwide. The overall cost of the PDSA scheme to IAU in 2017 was €45,962.

# **Diaspora Affairs**

In 2017, for the first time, Irish Abroad Unit had responsibility for an additional Diaspora Affairs budget line. In total 9 projects totalling €679,902 were funded under the Diaspora Affairs Budget line last year. This Diaspora Affairs expenditure was targeted at strategic projects that support the work of the Inter-departmental Committee on the Irish Abroad and existing Government Strategies, in particular those strategies which are most relevant to the wider work of this Department including Ireland Connected; the International Education Strategy for Ireland; Creative Ireland; and the National Tourism Strategy. A particular focus was on projects which supported returning Irish emigrants. Following a period of net outward migration from 2010, in 2016 Ireland returned to net inward migration with 26,428 Irish emigrants returning that year.

In 2017, the Department established a new mentoring programme called 'Back for Business', aimed specifically at returning emigrant entrepreneurs. Research suggests that time spent living abroad improves capacity to succeed in creating and growing businesses. At the same time, returning emigrants face challenges unique to them in setting up a business. These include gaps in personal and professional networks, support, and up to date local knowledge which would be crucial to successful establishment of new businesses. To address this potential deficit for returning emigrant entrepreneurs, 45 recently returned emigrants - 26 women and 19 men - from all over the country, enrolled in the Back for Business programme established by the IAU.<sup>8</sup> Of the participants, eight of those selected report that they already have some exports- thirty five (78%) state that they expect to be exporters in five years' time; 13 participants (29%) report having more than one person employed in the new business - all expect to be employers and half (51%) expect to employ ten or more in five years' time. The impact of this pilot project will be reviewed on completion in Summer 2018.

2017 saw an increase in the numbers of reports of 'barriers' to Irish emigrants wishing to return to Ireland to live. Building on the work of the Inter-Departmental Committee on the Irish Abroad which is chaired by the Minister of State for the Diaspora, the Department's 2017 Diaspora Affairs budget line also funded an independent economic report on difficulties experienced by Irish emigrants returning home.<sup>9</sup> This Report, which was considered by Government in March 2018, makes thirty targeted recommendations across nine thematic areas, which are now being taken forward across relevant Government Departments.

Through the Diaspora Affairs budget line, we also supported the 2017 *Ireland's Edge Conference*, which took place on 1-2 December 2017 in Dingle, Co Kerry. Ireland's Edge is an annual creative conference event that takes place en marge of the Other Voices Festival. As part of the collaboration with IAU in 2017, the theme of the Conference was *'Ireland – Migration Nation'*. Panel discussions included a debate on the experiences of Irish emigrants and of immigrants in Ireland and the ways in which Ireland could contribute to debates about migration, both at home and abroad, in a way that reflects the two sides of our migration nation.



# **Priorities for 2018**

Building on the work that has been achieved in 2017, in the coming period, our focus in diaspora engagement will be to continue to deliver support for our diaspora that is:



### **More Accessible Support**

The Department of Foreign Affairs and Trade has listened to organisations who have highlighted that the current procedures for the Emigrant Support Programme may be overly onerous for small community groups who have worthwhile projects that can have a particular impact for the Irish community in a local area. In 2018, additional funding of €300,000 is being made available to Irish Embassies and Consulates abroad so that they can fund deserving small local projects directly and quickly, without the need for small organisations to fulfil all the criteria and documentation associated with the Emigrant Support Programme which is more suited to larger projects and organisations.

For those organisations which do wish to apply through the Emigrant Support Programme, and to support 'pop up' type once off events, new administrative procedures are being put in place in 2018 to facilitate faster decision making for some smaller grants, enhancing the role of our Embassies and Consulates in Britain, the United States, Australia and Canada.

These are among a number of key changes being made to Emigrant Support Programme procedures to make this important funding more accessible to diaspora groups. The operation of these revised procedures will be subject to internal review once the 2018-19 ESP grant round is finalised, at which point it is hoped that further consideration can be given to the possibility of multi-annual funding for some organisations.

The availability of clear information is another key pillar of improving accessibility to the Emigrant Support Programme. Key guidelines and information documents have been extensively reviewed and are now all available on-line to assist interested organisations, and to make clearer information more available as to how decisions are made in respect of ESP grants.

### More Targeted/Prioritised Support

As set out in the Diaspora Policy itself, the key objective of the Emigrant Support Programme has been and will remain on supporting the welfare needs of the most vulnerable Irish individuals and communities abroad. This prioritisation of welfare support has been maintained over the review period, and will be maintained again in 2018-19.

While maintaining this commitment, we are also asking our partner organisations to do more to demonstrate the impact of our funding and the needs being addressed through ESP-funded projects. We are also encouraging more collaboration between organisations to ensure maximum impact for funding. Further to discussions at the Global Irish Civic Forum in May 2017, specific funding of €200,000 will be made available in the 2018-19 ESP grant round for new collaborative projects involving two or more organisations.

The Government will continue to prioritise Emigrant Support Programme funding for organisations and projects which support our undocumented citizens and their needs.

In terms of diaspora engagement more generally, we will work to ensure that the diversity of modern Ireland and our diaspora today is more fully reflected in our engagement and support. In addition to the Emigrant Support Programme budget, the separate 'Diaspora Affairs' budget line of €600,000 will be used as a Diaspora Development budget to extend the reach of the Government's current diaspora engagement. As well as engaging with traditional diaspora groups, opportunities will be proactively identified to extend our reach into additional groupings within the diaspora, reaching out in particular to 'non-traditional' or previously under-represented diaspora groups e.g. younger people, women, those with Ulster-Scots links, the LGBTQI community and the affinity diaspora.

### More Accountable Support

Since its establishment in 2004, the Emigrant Support Programme has represented an overall commitment of €159,924,963 by the Irish taxpayer in our communities abroad.

Over time our auditing systems have evolved to ensure best practice monitoring of the financial expenditure associated with these grants. Between 2014 and 2017, The Department of Foreign Affairs and Trade has undertaken 28 routine audits of ESP organisations using an external supplier. The annual figure more than doubled this year – with 11 organisations being audited. It is intended to increase the number of organisations audited in 2018, following a competitive tendering process, to facilitate a wider routine auditing and quality assurance function within the ESP.

In addition, we are also looking more to increased and improved measurement of the impact of the grants, with a view to identifying more clearly for the Irish public the difference that their support makes in the lives of Irish individuals and communities abroad. As part of this we are working closely with funded organisations to ensure that their own internal governance structures facilitate high impact engagement. For 2018, we have also amended further our monitoring and reporting procedures so that the outcomes and impacts of our grants are front and centre of the reporting by individual organisations.

### More Joined Up/Comprehensive Support

The period since 2015 has seen better connections and communications between diaspora organisations. The hosting of two Global Irish Civic Forums, in 2015 and 2017 was a key development in that regard, with organisations coming together to discuss common challenges and opportunities, and to forge direct and personal contacts and engagement. The importance and benefit of collaboration and joined up thinking by such organisations was a key theme at the 2017 Civic Forum. To support and encourage these efforts, for the first time the Government will ring-fence funding within the Emigrant Support Programme for collaborative projects involving two or more organisations. With regard to our community in Britain specifically we are funding a new project which is focussing on practical methods to address social isolation and the importance of inter-generational engagement in promoting healthy living for aging communities. Work is already underway through the GAA and Irish in Britain 'Good Match' project to link the older Irish community with newer arrivals.

This desire for more joined up action is also reflected in the work being taken forward by the Inter-departmental Committee on the Irish Abroad in ensuring there is better awareness within all Government Departments in respect of what others are doing to support and engage with the Irish abroad across a vast range of activities and issues.

#### More Strategic Support/Next Generation

As we look to the future of our diaspora engagement, in the face of changing patterns of international migration and, in particular, changing demographics in our traditional emigration and diaspora locations, there is no doubt that engagement through Irish culture and heritage will become more important. The 2016 Commemorations programme demonstrated how cultural and heritage projects engaged new audiences across many countries, and this is a legacy which can be built upon. In order to maximise the impact of this kind of engagement, it will be important for Ireland to utilise the entirety of the cultural infrastructure available to us globally and to develop and strengthen that infrastructure for our future needs.

Irish culture has a key role to play in the engagement of younger members and the next generations of our diaspora, which is central to Ireland's diaspora policy. Social media too will play a growing role in engaging our diaspora and the younger generations in particular. This is a specific priority for the Government's diaspora engagement efforts in 2018. In addition to the funding made available to Ireland's Embassies and Consulates for 2018, specifically to reach out to younger generations in our diaspora, and other groups who may be underrepresented in our engagement to date, further funding of €200,000 will be 'ring-fenced' within this year's Emigrant Support Programme grant round to support projects aimed at younger people and/or intergenerational engagement.
