Irish and British citizens continue to enjoy **reciprocal rights and privileges** on the same basis as citizens of the other State, including access to **employment, healthcare, all levels of education and social benefits**

THE IRISH AMBASSADOR VISITS CARDIFF



Ambassador Adrian O'Neill paid a visit to Cardiff on 14 June, and had a very positive meeting with the First Minister of Wales, Mark Drakeford. Together with Consul General Denise Hanrahan, they discussed the historically strong relationship between Ireland and Wales and how we could deliver on the priorities agreed in the Shared Statement and Action Plan. Covid restrictions meant that the Ambassador was only able to meet with a limited number of contacts from academia, the Irish community, and the National Museum, and he was also delighted to see the new Consulate premises first hand.

The Statement outlines our joint commitment to bringing Ireland and Wales closer, improving on a modern and vibrant relationship, made up of links and collaboration across many and varied spheres of activity. You can read about the Shared Statement [here](#).

PASSPORTS & LATEST TRAVEL REGULATIONS



Passports

Travel

From Monday 19th July, travellers arriving in Ireland from Great Britain will not be required to quarantine if they have valid proof that: they are fully vaccinated, or recovered from Covid-19 (NHS Covid Pass, vaccination status letter or paper vaccine card will all be accepted).

Travellers who are not fully vaccinated will need a negative pre-departure PCR test taken within 72 hours prior to arrival in Ireland. 14 days home quarantine will apply but people who take a second RT-PCR test, provided by the HSE, from day 5 after arrival can end quarantine early with a negative result.

Passengers arriving into Ireland/returning to Ireland must fill out the online Covid-19 [Passenger Locator Form](#) before departure.

From 19 July, children between the ages of 12 and 17 will be required to have a negative RT-PCR test taken within 72 hours prior to arrival into the country, unless they have valid proof of vaccination or recovery. Children of any age, travelling with accompanying vaccinated or recovered adults will not be required to self-quarantine post arrival. However, where one accompanying adult needs to self-quarantine, then all children must also self-quarantine.

Individuals travelling from Great Britain to Ireland via Northern Ireland should also complete the online Covid-19 [Passenger Locator Form](#) and follow the guidance above.

Due to the ongoing pandemic, and in particular the prevalence of the Delta variant, travel continues to carry an element of risk and travel rules are subject to change at very short notice, including the potential application of the “emergency brake” mechanism. We advise checking [Gov.ie](#) in case of updates before travel.

A NEW CONSULATE OPENS IN THE UK



We are delighted to welcome a new addition to Team Ireland in Great Britain with the opening of the Consulate General of Ireland in Manchester. The new Consulate General of Ireland for the North of England will work alongside & in partnership with the Manchester

office of Enterprise Ireland, which was established in April 2019 to support the growth of Irish businesses and trade.

The new Consulate is headed by Consul General Sarah Mangan with Vice Consul Carina O'Brien and will work to strengthen the many economic, community, and cultural links between the North of England and Ireland.

INTERREG PROJECT OF THE MONTH -BLUEFISH



The Ireland Wales 2014-2020 European territorial Co-operation programme is a maritime programme connecting organisations, businesses and communities on the West coast of Wales with the South-East coast of Ireland. In each newsletter, we will be highlighting a project in the programme, sharing the latest updates and how you can learn more about it

Bluefish was created to develop knowledge and understanding of the marine resources of the Irish Sea and Celtic Seas by addressing knowledge gaps regarding the effects on and potential vulnerability of selected commercial fish and shellfish from predicted climate change. Through the combination of art and science, BlueFish set out to demystify climate change, build resilience and raise awareness of the effects on the coastal communities. The programme was led by Bangor University, bringing together Aberystwyth and Swansea Universities in Wales, the Marine Institute, Bord Iascaigh Mhara, and University College Cork in Ireland.

The Bluefish team has recently completed their project operations and held a closing conference on 24 -25 June Called "Dynamic Seas", when they shared thier key findings on the impact of climate change on the fishing industry.
